### APPLICATION FOR PAID UP FOR LIFE (PUFL) MEMBERSHIP

1. This plan shall become available commencing with the 2007 membership year, beginning July 1, 2006. The Detachment of Minnesota SAL PUFL Committee shall be authorized to change the Minnesota SAL PUFL Membership plan subject to the approval of the Detachment Executive Committee and The American Legion Department of Minnesota Executive Committee.
2. The entire amount of the Minnesota SAL PUFL Membership must accompany this application unless other arrangements are approved by the Detachment PUFL Committee for the payment plan. No credit card payments will be accepted. NOTE: Current membership dues must be paid in full. If paying after October 01, pay the upcoming membership year to allow for processing.
3. There will be no refunds to any member that participates in the Minnesota SAL PUFL Membership Plan.
4. Increases in District, Detachment or National dues will be absorbed by the SAL PUFL Fund.

## **SONS OF THE AMERICAN LEGION DETACHMENT OF MINNESOTA**

### **PAID UP FOR LIFE MEMBERSHIP PROGRAM**

1. Funds must be paid all at one time and in one year with a maximum of quarterly payments upon the approval of the PUFL Committee.
2. The PUFL Chairman will be appointed by the Detachment Commander for a 3year term with the other two members on a rotating yearly basis.
3. The Department of Minnesota, American Legion will transmit dues to National, Detachment and District.
4. The dues are currently based on an average of \$15.00 per year. Currently, the dues that are sent into National, Detachment and District are \$13.00. The remaining income will be divided equally between the Squadron and the PUFL program (each Squadron will receive a \$5.00 credit per PUFL). The Squadron must have a current officers list turned into Department and they must be off Goose Egg in order to receive their reimbursement.
5. There are no refunds of dues at any time.
6. The PUFL program will be reviewed every five years, or as needed, to evaluate the profitability and productivity.
7. PUFL members may transfer Squadrons, within Minnesota, subject to the approval of the respective Squadrons.
8. Funds to be invested in a guaranteed interest-bearing account.
